SECTION 6 – ACCIDENTAL RELEASE MEASURES

Emergency Procedures Minor spills do not normally need any special clean-up measures – rinse with water. In the event of a major spill, prevent spillage from entering drains or water courses. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. As a water based product, if spilt on electrical equipment the product will cause short-circuits. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations.
